- Northcentral District Chuck Stotz

- O During this quarter i have visited all detachments in the northcentral district at least once. I conducted 2 officer elections and 2 officer installations. Seven detachments reported a total of 6231 volunteer hours including fundraising events and detachment program activities. Two detachments reported membership increases totaling 9 new members.
- Some activates reported by the North Central District
   Detachments include: collection of old flags at the Detachment's
   10th annual flag collection in April. The certification of a new
   V.A service officer
- o Aiding a homeless marine. Offering gifts that provided replacement / secure entry doors at the Servant Center, Greensboro. Financial support for the Women Veterans Honor Banquet. Providing six (6) mattress sets and six (6) sets of bedding to the Partners Ending Homelessness for newly housed Veterans. One Detachment began a new Eagle Scout Good Citizenship award program and two others honored nine scouts with the award. Many Detachments provided honor guards at funerals, presented colors or raised the flag at various public locations on memorial day and at special occasions as well as the laying of flags at the grave sites of our veterans. A few detachments continue their support of our veterans by visits to VA facilities. One conducts a bingo game to the enjoyment of our veterans. One detachment supports Wounded Warrior Battalion East and visits them regularly. This is just the short list of the good our Marine Corps League provides to our fellow Marines, veterans and the community at large.
- Central District John Dilday
  - o The 2017-18 fiscal year has resulted in some fantastic times and events. I am privileged to be serving five relatively small but very active Detachments. During the course of the year I have driven over 5,634 miles in visiting each Detachment. I have had the honor to serve as the Official Installation Officer for three of these Detachments. My wife and I both have taken part in many activities outside of just attending meetings with each of these Detachments throughout the year. These include Detachment

- Family social events. Attending several Eagle Scout COH events for one of the Detachments. Efforts are being made to get more Detachments involved with the Scouting program.
- Like many of the Detachments across the State and Country they are facing difficulties increasing membership and recognition. Three of the five Detachments have taken steps to become more active in the community by joining the local Chamber of Commerce which is providing them with another outlet for communicating within the community. By being pro-active they are beginning to see named recognition. Also, by participating in roadside trash pick-up they are getting signs recognizing the area they are designated to maintain.
- Many are now using technology to assist in name recognition by setting up and maintaining a Detachment Website. This has proven worthwhile with the number of hits they receive each month by people checking them out.
- Membership will continue to be a focal point for the upcoming year as we all know if we are not growing then we are doomed to failure.
- Again, I emphasize that it is an honor serving as the liaison between each of these Detachments and the Department of North Carolina and relish the many new friendships that have and continue to be developed.
- Southcentral Denny Mathias
  - O Suggestions for the 'Good of the League' as a result of your DVC activities: I will emphasize the need for at least one elected officer attends each Department meeting and that all elected officers attend at least one Department meeting each year. I will put forth for the next election cycle that my detachments request a commitment from each elected position to the above when they accept to be nominated. I recommend that the Department requests that all detachments make those commitments. A discussion should be had at the next staff meeting whether this should be a policy to be added to the Department Bylaws.
  - For this fiscal year the Charlotte Detachment awarded 11 scholarships among League members' grandchildren (2),
     MCJROTC and NJROTC students (9) totaling over \$8,000 as well

- as 27 Eagle Scout awards. Their gun raffle, BBQ fund raisers, annual golf tournament, and significant corporate donations have enabled them to provide support to these programs and help out members' families, area Marines and veterans.
- o The **PFC Charles D Hare Detachment** in Monroe had impressive Toys for Tots program by collecting 54% of the toys that were collected and served 26% of the children reported by the entire district; and this with only 16 members (6.4% of the District's membership). As small as their detachment is in numbers, their heart has demonstrated among the largest.
- o When it comes to volunteering, the **Stanly County Detachment** in **Albemarle** does not take a second seat at 75.7 hours per member. Their volunteer spirit shows when they provide their reports at each meeting. Their Scuttlebutt newsletter looks professionally produced. They by far lead the district in parking sign purchase and distribution at 65 signs, that's 26% of the department's sales by one detachment.
- O When honoring our Marine comrades when called by the Supreme Commandant, the **Cabarrus Detachment** shows the Concord community that Marines care about their own. Hardly a week goes by when I don't get a notice from them about the passing of another Marine or related service member in which they will have a League presence, showing their respects at the funeral homes and at the funerals.
- o PFC Bruce Larson Detachment always has the most activities going on of all the districts detachments. Sprinkling their meetings with guest speakers, keeps the members involved in other events around the community. Annually they honor their detachment's namesake, PFC Bruce Larson, with honor and recognition to the family. With members involved in unique activities such as Special Olympics, Bucket Brigades, Shooting Competitions, and USO, as well as the popular fund raisers of golf tournaments, scholarships, and Marine Corps Ball celebrations, their membership has been increasing with younger members joining.

 As you can see, these Southcentral District detachments all excel in various activities and are leaders in their own right. They all participate in community events and have found their niches, building on their own successes. I am proud to represent the Department when attending their meetings and am always warmly welcomed.

## 15. Commandant's Report – Jeffrey Jones

• Good morning Marines. This past year has flown by. I would like to start off by saying it has truly been my Honor to serve as your Department Commandant. As I said in Greenville I was going to have to slow down on my Detachment visits. I am still working on the house but I am starting to see a little light at the end of the tunnel. We are ready for paint in half of the house and when that is complete things should really start to progress. Since Greenville I have attended 9 different Detachments, 2 of which were 1<sup>st</sup> time visits for this year. As your Commandant I have attended 36 different Detachments. I have represented the Department at 119 events and have traveled a total of 25,051 miles. I have still not completed my mission to attend every Detachment. It is a much bigger task that I thought. I will give it another try this year. We do have 12 Detachments that are struggling and it looks like 1 will have to turn in their Charter. The Department of North Carolina as a whole is in good shape

On the 1<sup>st</sup> weekend in June, Team Turtle (myself, Rick Thomason, Laura Hamilton & Lorena King) participated in the Percy John Fulton Detachment 9<sup>th</sup> annual Mud Run. We had a great time representing the Department. I even wore my Department Cover and Devil Dog Collar throughout the entire course. We are planning to WALK the event again next year. We would love to have more members join us.

We have implemented a new fundraiser this year. I will talk about the Calendar program later today, and Rick will speak about our new Rifle Raffle. With these 2 fundraisers the 2018-2019 year we should raise over \$23,500 for the Department. Later today we will also talk about the budget. With this I plan to increase all of the Department positions that receive a stipend, and even add a position. I was unaware that our Department Sgt @ Arms did not get a stipend. Ralph is REQUIRED to be at these meetings and I think he should be reimbursed for his travels. By increasing the amount we will reimburse our Department Staff it will make it easier for them to serve you. ## 16. Report of Staff Officers

- Sr. Vice Commandant Rick Thomason
  - o Since my last report in April at the General Membership Meeting in Greenville, I have continued to attend Detachment meeting across the state, having attended three (3) Detachment meetings, participated in five (5) Officer Installations and three (3) Growls of the MODD. There has been another weapon purchased for the 2018/2019 raffle and a calendar produced for sale. Details later today. On 28 April 2018, my wife and I traveled to Glen Burnie, Maryland to attend the one-day Leadership College sponsored by the Department of Maryland. Also, in attendance from North Carolina were Scott Shermeyer, Lee and Pat Walker. Probably the highlight of this reporting period was the N.C. Marine Mud Run 2 June 2018 in Pinnacle, N.C. The Department Commandant, myself, the Adjutant and Paymaster represented the DoNC in the 5K event. While we did not set any records, we did finish as a team, with arms locked together as we crossed the finish line. The Percy John Fulton Detachment once again did a phenomenal job orchestrating the event. The moment that topped all others for the year came at the Mideast Division Conference when I was selected as the 2018 Mideast Division Marine of the Year. When asked to speak to the attendees, all I could think of to say was how much I owe to all the members of the Marine Corps League who have inspired me to strive for excellence at all levels. For the Detachments who welcome me at every meeting as if I was one of their own. For the individuals who asked the questions I didn't know the answer to until I researched them. To the Officers at all levels who set the standard by which all others are measured. And finally, to my wife who tolerates my obsession with the League.

- Since taking office in June of last year, I have traveled 24,482 miles representing the Department of North Carolina. Attended 34 different Detachment meetings from the Outer Banks to Cherokee.
   Participated in twelve (12) Officer Installations, three (3) General Membership Meetings, three Marine Corps Balls, Mideast Division Conference, National Convention and eighteen (18) Growls of the MODD.
- As my term of office ends, I see many successes within the Department for 2017/2018. It is my sincere hope that you will allow me to continue to serve as your Sr. Vice Commandant for the 2018/2019 term of office.
- Jr. Vice Commandant Scott Shermeyer
  - In the interest of time, I have submitted my full report in writing, and printed copies for you to read. Hopefully I've predicted attendance and printed enough to go around. Last year, after careful consideration, my gut feeling was to serve as your Jr. Vice Commandant, which is responsible for recruiting and retention. Part of the reason why this felt important to me was the massive changes in renewal process that we were going up against. Admittedly, many would agree that it was not a smooth transition, and we all faced some challenges. While we wanted to be proactive, it was tough to try to convince every member to pay again, despite renewing in some cases only a few months before. The plan looked good on paper somewhere...but out here in the field...well, situation normal, all fouled up (SNAFU). We aren't really done, though. Even though our Department terms of office are concluding, the renewal process and retention doesn't close until we see the membership rosters on September 30th. We're facing a higher than usual number of unpaid members, across the board. National and other departments are reporting similar situations, so we're not to blame. There was only so much that we could do. When we began this term, we avoided looking too closely at the numbers so as not to get bogged down. We wanted to be proactive, and we had to be patient. Now, we have to be persistent. Marines don't leave Marines behind...true story. We're facing detachment officer transitions over the past few months, and

we all know that sometimes a departing officer can't dump his pack soon enough and newly appointed paymasters might be left with a huge pile of who knows what, to sort out. Believe me, I know...been there done that, trial by fire. But, the good news is that we're in this together, and there is still time to get'r done. Some detachments have succeeded in retention, others have soared in recruiting. Some are obviously struggling. We need to close the gap. We lose some members naturally when they make their final PCS. As I previously reported, our trend has been a slow but steady decrease in membership. In order to better understand our situation and adequately report our statistics in real-time, I requested and obtained our DoNC member roster as of June 27, 2018 (unofficial). Some of the numbers may fluctuate over the next few days before the close of the quarter, but our numbers are way more realistic than if we looked back at March 30 roster. Although this situation report may seem long, it's hopefully chock-full of beneficial info that helps us see the many angles and better enables us to move forward and continue our mission of Marines Helping Marines. In retrospect, I've spent much of this year seeking first to understand. My endeavors have led me to look under the hood, taking seminars on non-profits, group dynamics, recruiting, retention, and building community. It's obvious that our challenges are similar to many other charitable, veteran, or service organizations and we are all facing shrinking numbers of cardcarrying members, which means fewer active members, and fewer detachments.

# Membership

Once the final June 30 roster gets sent out, we will update our statistics spreadsheets and share a link to the Google sheets for everyone who wants to delve deep into the numbers. As of our preliminary June 27 roster, here's where we stand: We began the year with 2,713 total members (PLM, Regular, Associate, Multiple) but this did not include honorary members or HAD members. We ended with 2,633 for a net loss of 80 members. As far as unpaid members of all sorts, we began with 1,075 and are down to 297.

# Recruiting

➤ Honorary Active Duty (HAD) Members Reference: National Bylaws, Section 600 - Membership Eligibility, Paragraph (d) HONORARY ACTIVE DUTY MEMBER - Detachments, Departments and the National Headquarters may, at the discretion of the respective Commandant, issue Honorary Membership to Active Duty Marines, FMF Corpsmen and Navy Chaplains, free of charge, for the entire tour of their active military duty. There are currently 15 DoNC Detachments that have 1 or more HAD members. As of June 27, we have a total of 197 HAD members, a 25% growth over the course of the year. However, of those, 72 HAD members are currently showing as unpaid, and thus risk dropping off automatically on the September 30 roster if they are not renewed.

Three detachments lead the way, for obvious reasons, in terms of recruiting HAD's. Onslow County Det. #262 with 59 (36 need renewed), Cherry Point Det. #1067 with 54 (0 need renewals), and Swansboro Det. #1407 with 29 (29 need renewed). Farther from the flagpole, Greater Greensboro Det. #260 has 21 (0 need renewals), Iredell County Det. #1097 has 9 (with 3 to renew), and

Percy John Fulton Det. #1075 has 7 (*0 need renewed*). These detachments have connected with their local USMC recruiting substation and partnered up with them. Wise move!

➤ Marine South Expo

During the Marine South Expo, I worked with Neil Corley, National Expo Review and MCL member Jack Jackson from Onslow County detachment to provide some southern hospitality to all of the DoNC, other MCL departments, and National staff. We stuffed goodie bags until running out of current Semper Fi magazines (the entire pallet, which we had to go out on a wild goose chase to locate the lost drive, arrived at 1500 on the last day of the expo.)

With the help of Tim Manchester, Alex Nevglovski, Greg & Lisa Ciesielski, and Jack Jackson, we were able to obtain about half as many HAD member applications as last year. Those applications went back with HQ MCL staff. Many of the Marines wrote-in their home of record address, so likely won't end up in Onslow County Detachment, nor on DoNC MAL listing. The moral of the story is that in a fast-paced hectic scene, it is difficult to fully engage everyone passing the booth. Marines seem to like swag, so maybe if we had something to hand out, more Marines might approach.

- > Transition Readiness Seminar
  - This is a 5-day seminar, which provides transitioning Marines and their families with the resources and tools need to reach their personal goals as they get ready to transition to civilian life. Along the path during their active duty phase, Marines develop an individual development plan (IDP) which then becomes an Individual Transition Plan (ITP) as the Marine Corps prepares them for separation/retirement/deactivation to return Veteran Marines to continue to serve as quality citizens.
- ➤ Marine for Life <a href="https://www.MarineforLife.org">www.MarineforLife.org</a>
  During our Fall Membership Meeting, we had a Marine for Life presentation by Marine Corps League Mark Munger, Southeast Regional Network Coordinator, Marine for Life. Mark joined Pound #370 MoDD and is a member of Swansboro detachment. Mark encouraged League members to participate in Marine for Life LinkedIn groups as a way to welcome a transitioning Marine

coming to their area. He challenged North Carolina to step forward and be the leader for other States to follow in regards to mentoring transitioning Marines. As he continues his involvement with the League he will continue to brief his leadership so that they can also brief higher. He stated that the CMC has shown great interest in finding ways for Marine for Life Network to be involved with the Marine Corps League. A positive step.



Marine Corps League - Veterans Information is listed as one of the resources under the category Veterans Service Organizations, with a link to page on national website that "Provides information on available resources for current and Veteran Marines and their family members." However, there are no distinct recruiting resources. Other veterans organizations such as the American Legion link directly to their national website home page.

## > Scratching the Surface

As far as this particular recruiting opportunity, realistically, we're probably only planting a seed. But, it all has to start some place. It may take a few years for transitioning Marines to feel the need to belong...but we need a consistent "selling point" to motivate younger generations.

We have an opportunity at MCAS Cherry Point to bring the Craven County Veteran's Council onboard for career fair, part of the transition assistance program. Our POC reached out to us from MCCS (Marine Corps Community Services) which means that our reputation is growing.

We will work earnestly to funnel as many of these Marines who will reside in NC to your specific detachments so that you'll have a chance to get them when they hit the ground running as veteran Marines.

# Regular Members

Activity-based recruiting with face-to-face conversation is a solid way to recruit members. Finding common ground, history, or interests is a great way to break-down barriers and get to know a prospect. Although we are an elite fighting force, and obviously our numbers are small, we seek the best and the brightest, inviting

them to join our ranks, and continue to serve as civilians as they once served their nation as Marines.

## ➤ Paid Life Members (PLM's)

Hey, PLM's are people, too. Don't forget them, even though they don't have to pay dues. Keep tabs on them and ensure that they haven't reported to Supreme Commandant without notifying your Paymaster first. Our June 30 roster will be sent out soon. Use that to conduct your PLM audit, certifying to national that you're aware that those PLM's listed on your roster are accurate. Account for your Marines! Report accordingly. PLM Audits should be signed by Det. Commandant and Paymaster and sent to DoNC Paymaster, who compiles them all and submits on behalf of DoNC to National.

## ➤ Members At Large (MAL)

The folks on the MAL list for NC are out on their own. We have little or almost no way to directly communicate with them other than snail mail. We will continue to provide the MAL list to detachments and encourage you to reach out to them. In some cases, it works, other times...just crickets and no response. As someone recently suggested, there may be MCL members who decided for one reason or another to step out from a detachment, but retain their PLM or maintain their MCL member status. However, there is no distinct benefit to the department once we lose contact and they are out in limbo on the "Island of misfit toys".

#### > MAL Detachment

One way we may be able to establish a win-win, is to stand up a special admin detachment and transfer our MAL's into a holding company. Essentially, it would be a bonafide MCL, DoNC detachment but not fully-functioning. There would be officers, but not much in the way of activity. This way, we could communicate with them and figure out ways to encourage them to join/rejoin local detachments. Several departments have already got these types of detachments going, so the protocol is already established. We wouldn't have to re-invent the wheel. The Department would have to vote to proceed and appoint a committee before we begin formal process. We could call this something fun, like Fight or Flight Detachment.

#### o Retention

Unpaid Members

Inevitably, despite every effort, sometimes Marines simply disengage and go permanently MIA. After a full year as delinquent, National will drop them off your roster, but even when their names disappear, we're left wondering, why? Conflict, failure to assimilate, fear of being tasked too much, cliches? These are some of the reasons that have come up. Paymasters, do what you can administratively to let your members know that it's not too late, we can get them back up to speed through reinstatements.

> Reinstatements

PFC Charles D Hare Detachment #914 was successfully able to reinstate Marine Steve E Kovacs, Jr. by obtaining an application for membership along with payment of \$20 reinstatement fee, which was included with MCL Membership Dues Transmittal and sent to DoNC Paymaster. Remember, if doing this, code the transmittal RI so that National processes properly.

> Fire Teams

One way to mitigate losing members when detachments fall below 15 members is to set up fire team support with adjacent host detachments. On March 1st, 2018 National Sr. Vice Commandant Dennis Tobin and National Commandant Wendell Webb approved the fire team concept. Looking forward, this is one way DVC's and DoNC Staff can further support.

presented to one detachment in each of the following membership categories:

- Category 1: Small Detachment total paid membership 15 to 50
- Category 2: Medium Detachment total paid membership 51 to 100
- Category 3: Large Detachment total paid membership 101>
- ➤ Category U: Detachments with less than 15 members are not eligible for consideration.

  - ➤ Detachment Recruiter of the Year Someone always seems to be the goto guy or gal when it comes to finding new members. Reward them with detachment recruiter of the year and shout out their stats. The member who missed out by one new recruit will probably step up the game for the next reporting period.

   My hometown detachment surprised me a few years ago with a milestone MCL membership pin. It turns out that they keep track of

tenure and present pins for every 5 years. Would you believe that this October will be my 25th year as member of MCL?

I'm working on implementing this with Cherry Point Det. as a way to celebrate years of membership. It's a small token of appreciation for continued service and may inspire someone who's taken a back-seat for a while to come around more or get more involved again.

MCL assisted & supported programs such as the MCL Good Citizenship Award presented to Eagle Scouts, Toys for Tots, Gunny Claus; military, veteran & patriotic holiday ceremonies, honor guard details, parades, etc. are outstanding ways to carry your message and convey the principles and purposes of the MCL.

Training & Indoctrination

Recently, a newly-elected officer from my detachment brought up some very interesting observations regarding detachment business. As the detachment goes through phases, new members may not get up to speed when there is an assumption that everyone knows what's going on, because we've done it for so long. Mentoring, buddy-system, training, welcome-aboard packets, and indoctrination are some ways to help transition new members into the fold. As someone who had to crash-course without the benefit of previous Adjutant/Paymaster, there is a lot to take in.

It was a full-day training covering all of the cool topics that MCL leaders should have a good grasp of. Although there were not earth-shattering discoveries, since we've already learned the hard way in various detachment and department billets, the distinct benefit to new MCL members finding themselves suddenly immersed in leadership responsibilities is immense. The resource guide alone was worth the drive and the registration fee. I have obtained digital files for all of the various resources and have begun to tweak them to suit DoNC.
- o If re-elected as your department Jr. Vice Commandant, one of my priorities will be to make this available in print and via PDF online for all of our detachments ASAP. Knowledge is power.
- Professional Development Program (PDP)
   Several years ago, resources were compiled on various aspects of the League. Ensure that your detachment officers have easy access to these resources, as well as: Officer's Guidebook, Detachment Bylaws, Department Bylaws, National Bylaws. Provide turnover folders.

- In addition to the required duties of the Judge Advocate as defined in the Department bylaws, I have been working on getting the department and detachments' bylaws updated. My action items include:
  - ➤ Department Bylaws Rewrite With the approval from the National Judge Advocate, Warren Griffin, I revised the numbering of our Department Bylaws to reflect the 2011 structure of numbering that was inadvertently removed in 2012. They are now posted on the Department website. The revising of these bylaws will occur this afternoon when proposed amendments are presented for a vote. The approved amendments will be incorporated and placed on the department's website.
  - ➤ Bylaws Hard & Soft Copy This goal is to have in the JA files an approved hard copy of the bylaws for every detachment and a matching soft copy (the editable file used to create the hard copy). This year after the National Convention in August, every detachment will have to review their bylaws to ensure they are still compliant with the National Bylaws and the Department Bylaws. Most detachments will have to revise their bylaws. I encourage each detachment to put their hands on their bylaws soft copy. Waiting to the time you need revisions made, is the situation I am warning the detachments to avoid.
    - To aid in this review endeavor, I will prepare a checklist of changes made in the National and Department Bylaws and Administrative Procedures that will affect our detachments. I will also prepare a model set of bylaws that, should a detachment elect to use instead of modifying their own, are compliant and can easily be customized for the detachment.
- O Part of my responsibility is to ensure the Department and the Detachments are compliant with the national and state laws and regulations. As I have reviewed bylaws changes that have been submitted for approval, I have also performed searches on the Secretary of State's and the IRS's websites. I have compared names and found that in most instances, the names of the organizations are not consistent with the bylaws submitted. Reasons are varied, however, when I notice the differences, I have made the detachment officers aware. It is their responsibility to correct the differences.

In order to get the detachment in front of the ball, I will be including an action item in the checklist of National and Department Bylaw changes for the detachment to review both the Secretary of State's and IRS's website to bring awareness to any differences with their bylaws. These changes will take time on each detachments' part and my part in reviewing up to 54 detachment's changes. I will be as expeditious as possible.

- Secretary of State Each detachment registered with the NC Secretary of State to incorporate. Among other information this registration includes the legal name and address of your detachment and the name and address of the Principal and Registered Agent. If any of this information changes, go to the Business Registration/Forms page and select the desired form. Your bylaws section that identifies your detachment name should be the same name on file with the SoS.
- National Scholarship The deadline for applying for a National Scholarship is 16 July with the winners being selected on 11 September. All details on the application process was sent in an email to all detachment commandants and adjutants on 28 June and are also are located on the National Website at https://www.mclnational.org/marine-corps-league-programs.html. Be sure to fill out the forms completely.
- O National Bylaws The National Bylaws and Administrative Procedures have been revised to be more readable, consistent, and in line with the documents' purposes. They, along with the 27 proposed amendments (several are redundant), are posted on the National Library website under CONVENTION. These will be reviewed and voted on at the National Convention in Buffalo in August. If you have any issue with how the National Office, Division, Department or your Detachments is governed to function, this is your opportunity to voice your opinion. I encourage each interested member to review the documents and notify your representative, who will attend the convention, of your opinion. If you want to express your opinion in writing, please do so to me or any elected department officer and your detachment officers. Please be specific in your opinions and offer alternative verbiage.

For fiscal year 2018 there have been no departmental grievance hearings. It is admirable to see that the detachments are addressing

issues that arise within their own detachments. I commend our detachments' leadership.

#### **ARTICLE FOUR**

**SECTION 400 - BY-LAWS** - A Department Convention may adopt Department Bylaws and Administrative Procedures which are consistent with the National Charter or the National Bylaws and Administrative Procedures, provided they have been approved by the Department Judge Advocate and subsequently by the National Judge Advocate, and provided further, that a copy of such approved Bylaws and Administrative Procedures shall be on file at National Headquarters. **(CH 9-09)** 

SECTION 405 - OFFICERS - A Department may have such elected and appointed officers as required by its Department Bylaws or in the absence of Department Bylaws as its Department Convention desires. Each Department, however, must elect a Commandant, Senior Vice Commandant, Junior Vice Commandant and Judge Advocate. The Commandant shall appoint a Chaplain, Sergeant-at-Arms, Adjutant, Paymaster or an Adjutant/Paymaster and other such officers as are deemed necessary to conduct the business of the Department. The standard Report of Officer Installation detailing the new Department Officers must be filed with National Headquarters no later than 31 July annually. SECTION 410 - MEETINGS - The Department shall hold one Convention each year between 1 May and 15 June. A report of Installation of Officers will be forwarded to National no later than July 1 annually. Department Staff meetings may be held as desired. Department meetings may be held during the months of September/October and March/April following adjournment of Department Convention, for transaction of official business of the Staff Officers, Department Committees and the Department for the transaction of such other business as may come before it. The Department Charter or copy, the National Colors, and Bible should be displayed at all business meetings. (CH 9-09) (CH 6-12) (CH 2 & 3-17) A. The hosting Detachment of the Quarterly meeting may charge a registration fee of \$10.00 (CH 2-17)

SECTION 415 - TRUSTEES - The Department Board of Trustees shall consist of the elected officers of the Department, the Junior Past Department Commandant or any appointed Past Department Commandant, and the Commandant of each Detachment. (CH 6- 14) SECTION 420 - DEFAULT - A Department which is in default of payment of monies from any source due National Headquarters or fails to submit its Department Officers Installation Report as of 31 July prior to the ensuing National Convention, such fact shall be reported to the National Convention Credentials Committee. The Department and its officers who do not comply with Article one, Section 105 (c) of the National Bylaws will not be recognized at the National Convention.

**SECTION 425 - FREEDOM OF ACTION** - Unless expressly forbidden by any Section of these Bylaws, a Department Convention and/or a Department Staff meeting shall be free to take such action and engage in such activities as are not in violation with Federal, State, County or Municipality Laws and Ordinances.

**SECTION 430 - CHARTER SUSPENSION, REVOCATION** - When a Department Charter is suspended or revoked, the National Board of Trustees upon written authorization by the National Commandant, certified by the National Adjutant/Paymaster, shall have the authority to assume the custody of the affected Department assets, both real and personal. These Properties and assets shall be turned over to the National Adjutant/Paymaster. The affected properties and assets will devolve to be control of the National Board of Trustees

until a new Department is formed at which time the affected properties and assets revert to the newly formed Department.

**SECTION 435 - QUORUM**- The quorum for Department Conventions and Department Staff meetings may be set by the Department Bylaws or in the absence thereof, by the Department Convention. Subj: Proposed Department Bylaws Amendment – ARTICLE FIVE
In accordance with the Bylaws and Administrative Procedures, Article Eight,
Section 800, the following is submitted for consideration by the body assembled at the 2018 North Carolina Department Convention.

### **CURRENT:**

### **ARTICLE FIVE**

**SECTION 500 - NAME** - No Detachment shall be named in honor of a living person. No Detachment shall adopt a name previously adopted by any other Detachment unless such other Detachment has surrendered or by revocation lost its charter.

**SECTION 505 - BYLAWS** - Each Detachment will adopt Bylaws and Administrative Procedures which are not inconsistent with the Department and National Bylaws and Administrative Procedures and shall be subject to approval by the Department Judge Advocate. In the absence of a jurisdictional Department, the National Judge Advocate shall be the approving authority for Detachment Bylaws and Administrative Procedures.

**SECTION 510 - OFFICERS** - Each Detachment must elect a Commandant, a Senior Vice - Commandant, a Junior Vice Commandant, and a Judge Advocate. Officers, both elected and appointed, will be selected by the Detachment members as they desire. The Detachment shall elect or appoint a Chaplain, Sergeant-at-Arms, Adjutant, Paymaster or an Adjutant/Paymaster, and such Officers as it deems necessary.

**SECTION 515 - MEETINGS** - The Detachment Charter or copy, the National Colors and Bible should be displayed at all business meetings

**SECTION 520 - QUORUM** - Each Detachment may fix the minimum numbers of members required to be present for the transaction of business, such member shall be stated in the Detachment Bylaws. (See Section 225 of Department Bylaws for guidance.)

**SECTION 525 - TRUSTEES** - The elected Officers of a Detachment shall be its Detachment Board of Trustees. However, a Detachment is authorized to appoint the outgoing Detachment Commandant or a Past Detachment Commandant to serve a one-year term as a member of the Board of Trustees.

**SECTION 530 - ELECTION - INSTALLATIONS OF OFFICERS** - Each Detachment shall hold an annual election of Officers between 1 September and 15 May. (CH 6-14)

A. Installation must be conducted no later than the last day of the month following the election.

- B. Report of Officers installation will be completed by the Detachment and forwarded to the Department Paymaster within five (5) days after the installation. The Department Paymaster will retain a copy and forward the report to the Department Adjutant, National Adjutant, and the Division National Vice Commandant. (CH 6-14)
- C. Notwithstanding the above, Report of Officers installation must be received at National Headquarters no later than 30 June each year. (National Administrative Procedures, Chapter 6, Section 620 applies.)

**SECTION 535 - DEFAULT** - A Detachment which is in default of monies from any source due National and such debt has not been satisfied as required by Section 105 (c) of the National Bylaws, or fails to report its Detachment's Report of Officers Installation as of June 30 prior to the National Convention, such fact shall be reported to the National Convention Credentials Committee, such Detachment and its Officers will not be recognized on the floor of the National Convention.

#### **SECTION 540 – MEMBERS**

A. Each Detachment shall be the sole judge of its membership, providing said person meets the requirements of Article Six, Section 600 National Bylaws. No Detachment, however, may accept as a member any person whose name has been stricken from the rolls of the Marine Corps League. Eligibility shall be verified utilizing the applicant's DD-214.

B. Once accepted as a member in good standing by the Detachment membership, that member may not be removed from the Detachment's roll except for cause (Chapter 9, National Administrative Procedures or by that member requesting transfer, (Section 710. National Administrative Procedures). C. An Associate Member in good standing in a Detachment who subsequently qualifies as a Regular Member as set forth in Article Six, Section 600 of the National Bylaws, upon vote of the Detachment to accept such associate member as a regular member, shall be transferred from Associate membership to Regular membership by forwarding the standard "Reguest for Transfer" form as set in Chapter Seven, Section 710 of the National Administrative Procedures clearly indicated on such form that it is a transfer from Associate to Regular membership. In the event that the Detachment voted not to accept an Associate Member as a Regular Member, such Associate Member may transfer to any other Detachment who agrees to accept him as a Regular Member or shall be transferred to Member-At-Large status by completing the standard transfer form as set forth in Enclosure Seven to the National Bylaws and Administrative Procedures.

**SECTION 545 - BONDING** - All Detachment Officers handling Detachment funds are bonded by the National Headquarters in the amount of \$10,000.00 with a deductible of \$1,000.00. Any additional bonding coverage desired for Detachment Officers shall be arranged by the Detachment at the expense of the Detachment (National Bylaws, Article Eight, Section 815 (m) applies).

**SECTION 550 - ADDITIONAL DETACHMENTS** - When a Charter is sought for a Detachment which is to be located within the limits of any municipality within which another Detachment exists the written consent of the existing Detachment shall accompany the application. Should such existing Detachment disregard a

request for consent, or refuse consent, the Department Commandant employing discretion may approve and recommend the granting of such charter. In the event the Department Commandant fails to act or refuse approval of the proposed new Detachment. An appeal may be made to the National Board of Trustees for its consideration and action. The action of the National Board of Trustees shall be conclusive.

### **SECTION 555 - CHARTER SUSPENSION, REVOCATION**

- A. The charter of a Detachment may be suspended or revoked for;
- 1. The persistent failure to maintain a minimum of fifteen (15) members in good standing;
- 2. The persistent failure to promptly forward funds due to the National body;
- 3. Acts and conduct bringing the Marine Corps League into public disrespect;
- 4. Willful violations of National Bylaws and Administrative Procedures;
- 5. The violation of Federal, State, or Municipal law or ordinances; or
- 6. Other activities detrimental to the good name of the Marine Corps League.
- B. The suspension or revocation of charter may be consummated by a Department Board of Trustees and/or the National Board of Trustees and shall be implemented in accordance with the provisions of the National Bylaws and Administrative Procedures in a manner considerate of the well-being and good name of all concerned.
- C. When a Detachment Charter is suspended or revoked the Board of Trustees of the Jurisdictional Department, or where a Department is non-existent, the Jurisdictional National Division Vice Commandant shall upon written authorization of the National Commandant, certified by the National Adjutant/Paymaster, assume custody of such Detachment's assets and liabilities. The Board of Trustees of the Jurisdictional Department shall, within the limits of such assets satisfy the liabilities of the Detachment in question. However, if a Jurisdictional Department is non-existent, the responsibility for satisfying the outstanding liabilities shall devolve to the National Board of Trustees upon receiving from the Jurisdictional National Division Vice Commandant, such assets and liabilities which are in the Jurisdictional National Division Vice Commandant's custody.
- D. The Detachments properties and assets will be held by the Department for a period one year or until a new Detachment is formed. Should a new Detachment be formed during that period, and the new Detachment retains the old Detachment name, ALL properties and assets will be returned. After one (1) year, the properties and assets will revert to the Department. The charter will be returned to National Headquarters and placed in the archives. All assets will then become the property of the Department. All ceremonial rifles must be accounted for per issuing regulations (Title 10, US Code 2572) either physically or through police/fire department reports.

### **SECTION 560 - VOLUNTARY SURRENDER**

A. The Charter of Detachment may be voluntary surrendered for such reasons as may be determined by the Detachment. Upon a determination that it is no longer practical to maintain said Detachment, the Detachment Board of Trustees shall immediately notify its Jurisdictional Department, or if a Jurisdictional

Department is non-existent, its National Division Vice Commandant in writing of its intent to dissolve and surrender its Charter. The Detachment shall then:

- 1. Call a Special Meeting of the Detachment by giving written notice of such special meeting to all members of the Detachment at least fourteen (14) days prior to such Special Meeting. If the regular meeting date of the Detachment is to be used for the Special Meeting, the afore said written notice must still be given to all Detachment members at least fourteen (14) days before the regular meeting date.
- 2. Upon consideration of the voluntary surrender of the Detachment Charter by the Detachment, if it shall be determined that the Detachment Charter shall be voluntarily surrendered and there are not a minimum of fifteen (15) members of the Detachment who remain ready, willing, and able to carry on the Detachment, then:
- a. The Detachment shall immediately notify, in writing, the Jurisdictional Department, or where such Department is non-existent, the Jurisdictional National Division Vice Commandant of the Detachment's vote to voluntary surrender its Charter.
- b. The Detachment shall determine from each member of the Detachment where such member desires to be transferred to upon surrender of the Detachment Charter.
- c. Prepare for each such member the standard application for the transfer form as set forth in Enclosure Seven of the National Bylaws and Administrative Procedures and pursuant to the provisions of Chapter Seven, Section 710 of the National Administrative Procedures and shall forward the same to the gaining Detachment for such action as the gaining Detachment shall deem appropriate. d. If a member of the Detachment fails to indicate where such member desires to be transferred to, or if a "gaining" Detachment shall not elect to accept a proposed transfer, then and in that event, the member shall be transferred to a "Member-At-Large" upon the surrendering Detachment submitting a standard transmittal form as set forth in Enclosure Six of the National Bylaws and Administrative Procedures.
- e. The Detachment shall, to the extent assets are available, satisfy all legitimate liabilities of the Detachment prior to voluntary surrender but shall not otherwise dissipate any assets of the Detachment other than the normal course of business of the Detachment.
- f. Upon acceptance of the surrender of its Charter, if the Detachment is incorporated, the Detachment shall take such action as is deemed appropriate to properly dissolve the corporation in accordance with applicable state law.
- 3. No surrender of a Detachment Charter shall be deemed effective or accepted until all members of the Detachment have been appropriately transferred.
- a. Upon acceptance of the surrender of the Detachment Charter by the Jurisdictional Department, or where such Department is non -existent, by the Jurisdictional National Division Vice Commandant, such Jurisdictional Department or Jurisdictional National Division Vice Commandant shall upon written authorization of the National Commandant, certified by the National Adjutant/Paymaster, assume custody of such Detachment's assets and liabilities. The Board of Trustees of the Jurisdictional Department shall, within

the limits of any assets of the Detachment, satisfy any remaining liabilities. However, if a Jurisdictional Department is non- existent, the responsibility for satisfying the outstanding liabilities shall devolve to the National Board of Trustees, within the limits of any assets received from the Jurisdictional National Division Vice Commandant of the Detachment.

b. After satisfying the legitimate liabilities of the surrendering Detachment, any Detachment properties and assets will be held by the Jurisdictional Department for a period of one (1) year or until a new Detachment is formed during that period. Should a new Detachment be formed during that period, and the new Detachment retains the old Detachment's name, all properties and assets will be returned to the Detachment upon the written authorization of the National Commandant, Certified by the National Adjutant/Paymaster, approving the reactivation of the surrendered Charter. After the one (1) year period, the properties and assets will revert to the Jurisdictional Department and will then become the property of the Jurisdictional Department. The Jurisdictional Department shall return the surrendered Detachment Charter to National Headquarters which the Charter shall then be placed in the archives. However, if a Jurisdictional Department is non-existent, the National Board of Trustees shall hold any Detachment properties and assets subject to the same terms and conditions as set forth above for a Jurisdictional Department except that at the end of the one year period, the Detachment properties and assets shall revert to National Headquarters and will then become the property of National. c. All ceremonial rifles must be accounted for and disposed of by the surrendering Detachment as set forth in the issuing agreement and regulations (Title 10, United States Code, Section 2572), either physically or through police/fire reports of any weapon not currently in the Detachment's possession. (CH 9-09)

**PROPOSED VERBAIGE CHANGE:** Only the proposed changed sections and subsections in ARTICLE FIVE are presented here without editing marks follows.

### **ARTICLE FIVE**

#### DETACHMENTS

**SECTION 505 - BYLAWS** - Each Detachment will adopt Bylaws and Administrative Procedures which are not inconsistent with the Department and National Bylaws and Administrative Procedures and shall be subject to approval by the Department Judge Advocate.

**SECTION 550 - ADDITIONAL DETACHMENTS** - When a Charter is sought for a Detachment which is to be located within the limits of any municipality within which another Detachment exists the written consent of the existing Detachment shall accompany the application. Should such existing Detachment disregard a request for consent, or refuse consent, the Department Commandant employing discretion may approve and recommend the granting of such charter. In the event the Department Commandant fails to act or refuse approval of the proposed new Detachment, an appeal may be made to the National Board of Trustees for its consideration and action. The action of the National Board of Trustees shall be conclusive.

**SECTION 555 - CHARTER SUSPENSION, REVOCATION** 

E. When a Detachment Charter is suspended or revoked the Board of Trustees of the Department shall upon written authorization of the National Commandant, certified by the National Adjutant/Paymaster, assume custody of such Detachment's assets and liabilities. The Board of Trustees of the Department shall, within the limits of such assets satisfy the liabilities of the Detachment.

SECTION 560 - VOLUNTARY SURRENDER

- A. The Charter of Detachment may be voluntary surrendered for such reasons as may be determined by the Detachment. Upon a determination that it is no longer practical to maintain said Detachment, the Detachment Board of Trustees shall immediately notify its the Department. The Detachment shall then:
- 1. Call a Special Meeting of the Detachment by giving written notice of such special meeting to all members of the Detachment at least fourteen (14) days prior to such Special Meeting. If the regular meeting date of the Detachment is to be used for the Special Meeting, the afore said written notice must still be given to all Detachment members at least fourteen (14) days before the regular meeting date.
- 2. Upon consideration of the voluntary surrender of the Detachment Charter by the Detachment, if it shall be determined that the Detachment Charter shall be voluntarily surrendered and there are not a minimum of fifteen (15) members of the Detachment who remain ready, willing, and able to carry on the Detachment, then:
- a. The Detachment shall immediately notify, in writing, the Department of the Detachment's vote to voluntary surrender its Charter.
- 3. No surrender of a Detachment Charter shall be deemed effective or accepted until all members of the Detachment have been appropriately transferred.
- a. Upon acceptance of the surrender of the Detachment Charter by the Department shall upon written authorization of the National Commandant, certified by the National Adjutant/Paymaster, assume custody of such Detachment's assets and liabilities. The Board of Trustees of the Department shall, within the limits of any assets of the Detachment, satisfy any remaining liabilities.
- b. After satisfying the legitimate liabilities of the surrendering Detachment, any Detachment properties and assets will be held by the Department for a period of one (1) year or until a new Detachment is formed during that period. Should a new Detachment be formed during that period, and the new Detachment retains the old Detachment's name, all properties and assets will be returned to the Detachment upon the written authorization of the National Commandant, Certified by the National Adjutant/Paymaster, approving the reactivation of the surrendered Charter. After the one (1) year period, the properties and assets will revert to the Department and will then become the property of the Department. The Department shall return the surrendered Detachment Charter to National Headquarters which the Charter shall then be placed in the archives.

Should it be determined after careful investigation by Department Judge Advocate that a member does not have the required qualifications for membership, in accordance with National Charter and the National Bylaws of the Marine Corps League (Chapter Six Section 600 (a) such member shall be dropped from the rolls immediately. Proper notice of such action and the reason therefore shall be expedited to the jurisdictional Department and National Headquarters. (See Chapter Six, Section 625 of National Bylaws).

SECTION 650 - DUAL MEMBERSHIP - (Membership in more than one Detachment by the same individual) When a member of the Marine Corps League becomes a member in good standing in more than one Detachment, such membership in the subsequent Detachment shall be counted for voting strength at Department and National Conventions only as an associate member. Such member shall be a regular voting member in the Detachment of such member's greatest tenure unless he/she makes a signed written request for transfer of voting rights in triplicate to the receiving Detachment; which upon acceptance shall forward the copies of the transfer of voting rights to National Headquarters via the jurisdictional Department Adjutant/Paymaster, if a Department exists. The transfer form, Enclosure Seven, National Administrative Procedures, will be utilized for the purpose of transfer of voting rights to another Detachment.

billed in the amount of seventy -five (75.00) dollars and a like amount annually until such proof of incorporation is on file with National Headquarters. A Department or Detachment, which fails to remit its payment to National Headquarters shall be in default as is provided in National Bylaws, Article Four, Section 420-DEFAULT. A new Department or Detachment will have two (2) years from the issue of their new charter.

A. Article Seven applies to Chapter Eight, Administrative Procedures, Section 810, 820, 830, 840, 850, 860, and 870.
