 - i. Over the course of this past year, it has been my pleasure to attend at least 85% of the Five Detachments meetings that are in the Central District. Over this past quarter it has been my pleasure to handle the installation ceremonies of two of the Detachments. As with most of the other Detachments across the Department all five Detachments held their elections and in some of them, they had a continuity of the Staff to repeat a

second term and in some a new slate of Staff was elected and installed. Each Detachment has in place some very motivated Marines and they are willing to put forth the effort to improve their presence in each of their communities.

As far as renewal of members the five Detachments had a 97% renewal rate with a couple Detachments had 100% renewal. Each Detachment are making a concentrated effort to bring in new members and all but one Detachment has shown a growth in membership.

Events that have been promoted over the past quarter and this past year include:

- 1) Of course each Detachment had very successful Toys 4 Tots programs.
- 2) One Detachment, Sanford, participated in a local community all day event and were highly commended by publicity in the local Newspaper. They also did a T4T Christmas in July fund raiser, with the intention of doing this again in 2022.
- 3) The Shawn Knivsley Detachment created and presented a monetary scholarship for a local high school senior. They have spearheaded a monetary fundraiser to set up a memorial in a local cemetery for the Gold Star Mothers program. Have started a Young Marine Program in the Fayetteville area. Active in Eagle Scout recognitions. Work with the local community programs feeding the homeless in their area.
- 4) The Sandhills Detachment has been successful in adding new members by their activities in their community. They have plans in action to form a Young Marine program. They are forming a Honor Guard to be available to participate in local community events and also funeral details.
- 5) The Richmond County Leathernecks is a very small Detachment but their presence in the community is well recognized by their participation in the local Chamber of Commerce. Even with the small numbers their T4T program

was a tremendous success for Richmond County.

6) The Harnett County Detachment is another very small in numbers Detachment but they also are making themselves well recognized in their community. Their T4T program is also tremendously successful for the kids of Harnett County.

It's hard to believe that a year has gone by this fast. It feels like yesterday that I assumed the responsibilities of Sr. Vice Commandant. It's been a year learning and acquiring knowledge on proper protocol issues and growth within the MCL by-Laws and procedures. Even though I've been a member of the League for 20+ year's things are continuously changing and the learning process never stops.

Since our last meeting raffle tickets and coin sales have been underway. With regards to the Patriotic flag raffle: Of the 1100 tickets printed a vast majority have been sold. Originally 1000 tickets were printed but 100 were lost so 100 had to be printed again. Still leaving a total of 1000 tickets to be sold. I encourage the Detachments, DVC's, or anyone who has tickets to ensure that they are dropped in the ticket jar at the DoNC convention check-in table during May 13-15 in Raleigh, NC. The winner will be drawn Saturday evening, May 14, 2022 at the banquet.

The roll out of the unique DoNC coin was positively received. Six Hundred (600) coins were made and by the end of the spring membership meeting the cost of the coins had been covered and the remaining monies collected were pure profit for the Department. There are still some coins remaining and are available for \$12 each should you need to purchase more.

An additional small fundraiser was the sale of remaining inventory of a T-shirts and embroidery business that own. All I requested was that my costs be covered and the League could retain the difference.

The sale/cost was 1 shirt for \$15; 2 shirts for \$20 or 3 shirts for \$25. Sizes are limited but definitely would make great gifts for family, friends, neighbors, fellow veterans, or giveaways. These will be available at the convention so everyone has an opportunity to participate.

 - b) Report

Purpose:

To create awareness of the full support the Marine Corps League provides to the Marine Toys For Tots Foundation. To capture all data from local Detachments who support the Marine Tots For Tots program.

To share lessons learned, marketing ideas and unique fundraising events with the MCL membership. To generate a report by the MCL National Toys For Tots Liaison for each National Mid-Winter Conference and National Convention. To encourage Detachments not currently involved with the Marine Toys For Tots program to come aboard.

Background:

The *Marine Toys For Tots Foundation* is the official IRS 501(c)3 non-profit organization that administers the TFT program nationwide. They oversee both the Marine Corps Reserve Unit Coordinators and approved Local Area Coordinators. The Marine Toys For Tots Foundation currently requires all Local Area Coordinators and Marine Corps Reserve Unit Coordinators to submit a comprehensive AAR directly to the TFT Foundation at the end of each campaign season. Marine Toys For Tots is also an official program of the Marine Corps Reserve.

If a Detachment supports a Marine Corps Reserve Unit, your numbers are rolled up into their data. The MCL at the national level has no way to track or give you credit for all the hard work done by your Detachment.

If your Detachment is an official sponsor of a local campaign, MCL National will receive your data beginning with the 2018 campaign season.

Completing the MCL Detachment Toy For Toys AAR:

The form is self-explanatory. Just answer the questions. You may include any noteworthy or unique event flyers, marketing ideas, fundraising events or volunteer appreciation awards/certificates, etc. We understand that Detachments who support a Marine Corps Reserve Unit may have trouble estimating the number of toys or monetary donations when conducting joint USMCR/MCL operations. Typically the USMCR takes all the toys and donations with them. Do your best. What we are really looking for are any MCL specific events or fundraisers that only the MCL participates in and donates directly to a USMCR program (i.e. 1-Det has a table in the local mall worked only by MCL membership and collects donations and toys...count those toys and monetary donations prior to handing them off the USMCR; 2-Det holds a Rifle Raffle with all proceeds going to TFT; 3-Det makes a monetary donation out their Detachment funds to a local TFT campaign).

NOTE: A Local Area Coordinator, where the MCL Detachment is your sponsor, is NOT required to also complete our internal MCL AAR unless you want to provide information that would be beneficial to the group.

Toys For Tots & MCL:

Detachment support of Toys For Tots must be coordinated with your Local Area Coordinator or Marine Reserve Unit Coordinator. That person is the only one who can authorize you to use Toys For Tots trademarked logos and should be made aware of any Toys For Tots monetary donations, toy collections or events in your area. Checks should made payable to 'Toys For Tots' and given to the Local Area Coordinator for deposit.

Detachments can apply to become an official sponsor and create their own local campaign if you are in an area that does not have a TFT campaign or if the current TFT campaign covers a large area or multiple counties. Maybe they would support you breaking away and creating a separate campaign in your Detachments area of responsibility. This needs to be coordinated with the current TFT campaign and the Marine TFT Foundation. Applications to become a new Local Area Coordinator must be submitted in the Spring. A TFT Coordinators Conference is held in September.

1. Eagle Scout Program – Charles Minton

a) I have only received reports from 2 Detachments, a total of 13 Eagle Scout Good Citizenship Certificates for the fourth quarter. Since the Department convention is being held in May this year the Detachments haven't submitted their fourth quarter reports which aren't due until June.

I will modify my report for the fall to show what we have presented for the fourth quarter and total for the year.

To Date the Department has presented a total of 168 Certificates.

The National Boy Scout Committee is working on several projects that should make the program run smoother and be more unformal. They are working on standardizing the programs structure and presentation process along with reporting of numbers.

They are also looking at ways to recognizing the other Scouting entities (Venturing crews, Sea Scouts and Girl Scouts) who each has their own highest award that is equivalent to the Eagle Scout award.
