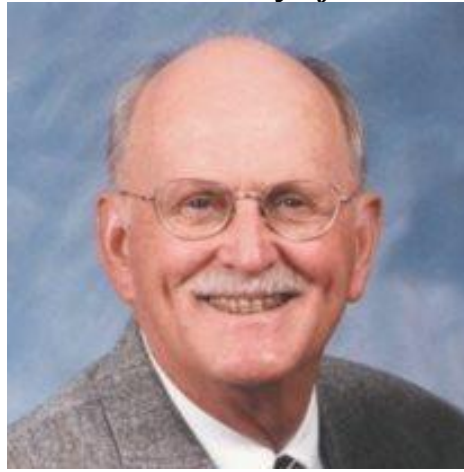

Mr. Aaron Dean Murdock, 79, of Asheboro, NC, died Tuesday, August 5, 2014, at The Randolph Hospice House after a valiant struggle with ALS.
