### Chaplain's Corner **Chaplain Winston Shearin**

On July 4th, we celebrate the adoption of the Declaration of Independence by the second Continental Congress of the United States of America. Two days earlier in 1776, the notion of independence was passed as 12 of the 13 colonies voted in favor of a motion to become inde-

pendent from Britain was when the Declaration of Independence was officially adopted. It would take a month before the document was validated by all of the signers. We are sometimes tempted to think of this event as a static episode that happened and is gone, a shadow in the memory of our history, but we err when we do so. For the freedom that came with that declaration required and still demands constant vigilance. The closing words of which capture so well our dependence upon God and upon each other for our liberties: "with a firm reliance on the protection of Divine Providence, we mutually pledge to each other our Lives, our Fortunes, and our sacred Honor." I suspect Marines and their families understand this necessity as well, or even better than most, for like our predecessors, we hand down from one generation to the next the mantle of service in the stewardship of freedom. At our last meeting Iwas impressed by the legacies of freedom embedded in our Marine Corps League. As we stood to sing our Hymn, I saw the faces of young Marines, still serving on active duty, and the faces of older ones who served in wars long ago.
