I worked with the Gunny Claus program during the month of December

#### **Report of Staff Officers**

#### • Sr. Vice Commandant – Jeffrey Jones

First of all, I would like to thank all of you for making these quarterly meetings. Your participation is what makes North Carolina one of the Best Departments in the Marine Corps League.

I started this quarter off by attending the funeral of our Past Department Commandant and 50<sup>th</sup> Chief Devil Dog George Barrows. George had a good send off as there was around 75 Marines present. The funeral possession was about ¾ of a mile long, led by a Caisson. At the end of January, myself with the help of Rick Thomason, Steve Tracy, Scott Shermeyer, Gunner Ski, Tim Manchester & Jerry Brown took down the ramp at George's house. The ramp stayed up 2 months and 2 days. The ramp was paid for by the charity organization "Military Missions in Action". The ramp was taken down in sections and is being stored in Wilson. It will be available for use by any Department member that needs to use it.

I have attended 10 new Detachments this quarter making my yearly total of 37 and a total of 56 Detachment visits. This quarter I traveled a total of 6,540 miles

for a yearly total of 22,377 miles so far. I still have 19 Detachments to visit and I am trying my best to visit them all.

I have also attended a North Carolina Veterans Advisory Committee meeting and a North Carolina Veterans Council meeting. Last weekend I attended the Mid-Winter conference in Fredericksburg, VA where a lot of good information was passed. The new database that Charles mentioned will be up and running nine weeks from the day it is ordered. This will be the sole server of the Marine Corps League. We will not be sharing this with any other company like we did the Blum server. That server we shared with over 150 others and was corrupt.

To date, the Department had cleared \$2,519.01 on the raffle of the rifle. It will be drawn for on June 3<sup>rd</sup> at the DoNC Convention. Let me know if you need tickets. I still have a few left.

At our January quarterly meeting that was affected by the weather I announced that I was running for your Department Commandant. I am asking for your support.

# Presentation of the Department's Data Retained from The Quarterly Reports by The Adjutant

The Excel Spreadsheet depicting data pulled from Quarterly Reports was displayed on the overhead screen and reviewed. Membership was queried as to whether they wanted to see the spreadsheet once a quarter at the meeting, or would they like to see it on their computer and spend time comparing data. Membership implied they would like to receive it vis email. Various sections of the spreadsheet were discussed and a general overview given as to how to manipulate the fields. No questions were posed.

#### Report of Staff Officers (Continued)

#### Jr. Vice Commandant – Howard Boyd

Over the past year, the Department of North Carolina's membership had an increase of thirty members now totaling 2,347 members. Our delinquency list decreased by 84 members and now stands at 434 delinquent members. While these numbers are positive from a year ago we need to continue our diligence in obtaining, growing and retaining membership.

The Department currently has 57 Detachments. Thirty-seven (37) small Detachments with membership between 15 and 50 members, Thirteen (13) medium Detachments with membership between 50 and 100, and Two (2) large Detachments of over 100

members. There are five (5) Detachments (872, 1186, 1222, 1282, and 1320) with less than 15 members however three of these 5 detachments (1186, 1222, and 1320) can increase their membership to over 15 by reducing their delinquency list. Department By-laws Section 555 states that a Detachment may be suspended or revoked for the persistent failure to maintain a minimum of fifteen (15) members in good standing. The Department is not in favor of revoking any Detachment as long as they show efforts of improvement.

Detachments, please remember that at the end of each budget year the Department presents a Junior Vice Commandant Recruitment and Retention Award as a membership incentive. This award recognizes those Detachments with the highest percentage of membership increase and highest percentage of decrease in unpaid members over the year. This information will be collected from the March 2016 roster to March 2017 roster. This award is presented to one Detachment in each division small, medium and large. Now is the time to begin working toward obtaining this award.

I attended the Midwinter conference, George Barrows funeral and visited three Detachments since the last Quarterly. Asked if there were any questions.

#### • Judge Advocate – Scott Shermeyer

I attended the Midwinter Conference for the first time this year. Impressed that there were over 200 hands on deck for the conference. Also, attended the funeral of George Barrows, Sr., participating as the Honor Guard and accompanying the casket to the point of internment at the Veterans Cemetery in Jacksonville.

While at the Conference, I first heard of the 50/50 term. The MCL National is looking to have the membership reach a point of 50% under 50 years old and 50% over 50 years old. Understandably there is some lack of participation by the younger group of Marines. We must work on making the MCL interesting to them. It took me 10 years to really get interested in the League and its functionality. 10 years after that, (20 years since joining) I am your Department Judge Advocate.

WE did lose one Marine to Chapter 9 proceedings last year. We exhausted all possibilities of settlement and proceeded as per the National Bylaws. A meeting was scheduled for the Fall Quarterly, but all parties were not available. It was then rescheduled for the Winter Quarterly, but was not held because of snow. We finally convened the board and heard the case. A decision was rendered that was the best for all parties and the ruling processed through channels. The right to appeal still stands at this time. Feel free to give me a call at any time regarding matters of the Leagues purposes and procedures.

The matter of the Blums has been resolved and is no longer an issue. A nondisclosure agreement was signed by both parties and remains in effect. We will never know the full term of settlement by the parties.

The National Judge Advocate, Johnny Baker, has proposed the complete revision of the National Bylaws, reducing it to 18 pages of Bylaws, with everything else coming under Administrative Procedures. He then proposed that all administrative Procedures come under the direct control of the National Board of Trustees, removing it from the control of the general membership. There would be no discussion or oversight by the Department or Detachment. This the DoNC JA was in effort to place all subordinate groups under the direct control of the National BOT. He does not agree with the proposal. Discussion followed with much dissent over the proposal. Efforts to clarify the proposal were made by Howard Boyd, Ken Parker and Bruce Rakfeldt. Discussion of voting for bylaw changes followed. Question from the floor as to whether or not there was a template for the Detachments to use for Bylaws. JA advised that there is no official template other than to utilize another detachment that can be amended to suit their needs. No further questions.

Proposed bylaws were read to the general membership by the Chairperson. Discussion followed, given by the DoNC Commandant and DoNC Judge Advocate for clarification. DoNC SVC reminded everyone that we will be voting on the DoNC Convention site for 2019 at this year's convention. We vote two years in advance of the convention to allow plenty of time for preparation.

#### Aide-De-Camp – John Dilday

Report summarized by the DoNC Commandant... John wished to thank the Asheville Detachment and the Blue Ridge Detachment for all they did to bring this Quarterly Meeting about. The 2017 DoNC Convention will take place on June 2<sup>nd</sup>-4<sup>th</sup> in Raleigh at the Doubletree Hotel by Hilton. Details will be sent out as to reservations and registration. The fall Quarterly will be held in Calabash, providing they can find a venue large enough to accommodate the Department. Locations for the 2018 meeting are being set up now and will be published when confirmed. John would like to personally thank all of you who stepped up to support GySgt. Jason Carter and his family. He is now at the Wounded Warrior Battalion East, Camp LeJeune in therapy. If you would like to be considered for the 2019 DoNC Convention, now is the time to get your letter in so we may consider it at the convention and vote upon it during the business session.

#### **Report of Project Leaders:**

#### Young Marine Program – Ralph Farthing

It was requested that all the DVCs check with their Detachments to see if they support the Young Marines Program. If they do, would you please have them send him a report of what is going on in their area. Unless he receives a report, he has no idea of what is happening. He has no other contact with the Young Marines. He just received a report this morning.

#### VAVS Program – Ken Parker

Reports submitted by 17 Detachments indicate over 3,204 hours reported. Ken continued to elaborate on the criteria for true reporting of VAVS hours as per the VA guidelines. We need to track the volunteer hours to separate the true VAVS hours from community service hours and service to veterans away from the VA. Commandant verified that we were working on a change in reporting to separate the hours. Discussion followed, detailing instances of hours in service to the veterans and whether they qualified as VAVS hours.

#### Fund-Raising – Jeff Jones

The M1A rifle raffle has cleared \$2,519.01 so far. Tickets are still available. More challenge coins were ordered to fill orders in excess of the initial order. Coins are still available if you did not get them on the initial order.

Commandant Minton asked for a motion from the Floor to accept the Officer and Committee reports as given or submitted. Motion made, seconded and voted upon. Motion passed without dissent.

#### **New Business**

DoNC SVC, Jeffrey Jones requests a motion to fund new Women Auxiliaries that start up with a \$100.00 donation. Motion made and seconded. Discussion opened and question asked as to whether or not there needed to be a line item added to the budget. The SVC stated that the line item existed for the new Detachments, so the new Auxiliary could be added to the description and not have to add another line item. Vote taken and motion passed without dissent.

DoNC JA, Scott Shermeyer makes a motion to present the Onslow County Auxiliary with a check for \$100.00. Motion made and seconded. The money was already presented to the Auxiliary in August at time of Charter, but was never brought before the Department due to a lack of quorum at the Quarterly Meeting. Motion is for a formal record of disbursement. Vote taken and motion passed without dissent.

DoNC SVC, Jeffrey Jones request the establishment of a "Humanitarian Fund" to be added to the budget as a line item. The Commandant and the Staff Officers would make the determination as to fund the request. The project to build the ramp for George Barrows was one example. Another was a request for financial assistance by a Marine Suffering from PTSD who was trying to relocate to California be closer to home. We had to hold a phone survey of the Staff Officers to authorize the \$500.00 payment to the family. Question raised as to whether the Fund will be maintained at \$1,000.00 all year, or for the entire year? DoNC JA clarified the difference between the non-discretionary funds and the allocated funds. Suggestion from the floor was that each Detachment donate \$50.00/year to the Department for the fund. That would be over \$2,500.00/year. Question asked as to whether this would be a onetime payment to the Marine, or could they keeping requesting our help? Discussion resulted with clarification by Howard Boyd and Jeffrey Jones. Guidelines will have to be established, hopefully before the next Quarterly.

#### Good of the League

DoNC JA, Scott Shermeyer brought up the fact that no Marines were reported as deceased at the Midwinter. SVC Jeffrey Jones clarified that it was a National issue, not our reporting. DoNC Chaplain confirms that the reports are being sent in.

Commandant Laura Hamilton addressed the membership on the issue of the Department Paymaster and the Department Adjutant having to provide their personal computers, recording devices and thumb drives for the documentation of Department business. To insure a smooth transition from one Adjutant/Paymaster to another, at

time of appointment, she recommends that the Department provide them with computers and a recorder to perform the job they are assigned. DoNC JA, Scott Shermeyer addressed the membership. He will provide both Computers, associated software and thumb drives required to do the jobs of the Adjutant and Paymaster, through his business, Carolina Computer Care. When he took over the job as Adjutant, he assumed the Department had a computer. He found out it belonged to Bruce Rakfeldt. He continued on using his personal computer. He will not supply a recorder. He added that they were still working on the sound system, of which he has donated a great deal of the material. Hopefully it will be complete by the DoNC Convention.

DVC Chuck Wright addressed the membership. Gunny Claus is represented at this meeting by four of the seven actively involved members of the program. Last year they saw over 11,600 children in 23 days. Some of the children were in Texas and California. We go where we are requested. \$11,000.00 was raised in 90 days this past year. This year they are starting earlier so to raise more money for the children and to cover expenses. Thirty-One Industries donated \$8,000.00 worth of gifts for the children. We have 6,000 items still in storage for the upcoming Christmas season from Thirty-One. Question asked from the floor as to what happened to the \$15,000.00 his detachment donated to the Gunny Claus Program. DoNC Commandant Minton spoke up to say it went to the Bike Battalion and not the Gunny Claus Program. They are looking at not allowing that to happen again this year. The funds were supposed to go to Gunny Claus. Question from the floor as to whether it was a conflict with the MCL. Commandant Minton gave an overview of the Program and a visual representation of the Gunny Claus uniform was displayed overhead.

Commandant Minton announced he will be running for Junior Past Commandant next year.

SVC Jeffrey D, Jones announced his intent to run for the position of Commandant,

JA Scott Shermeyer announced his intent to run for the position of Junior Vice Commandant.

Adjutant Rick Thomason announced his intent to run for the position of Senior Vice Commandant.

JVC announced he would not be running for office this time because of other commitments. He thanked the membership for all the support he has had over the last four years.

SVC Jeffrey Jones announced that Denny Mathias has announced his intent to run for the position of Judge Advocate. A letter of intent has been sent out to the Department. Glen Perkins announced his intent to run for the position of Junior Vice Commandant.
