B. Subject of discussion

- 1. Spring and Fall Membership meeting uniforms.

- 2. Email request from John Dilday 2025 and 2026 conventions

 - b. He is asking for \$2500 in addition to the \$200 that is currently in the budget for each convention.

 - e. This will be presented to the membership at the Fall Membership meeting.
 - f. The current stipend may need to be increased in general.
 - g. SOP for hosting needs to be formally adopted into the Administrative Procedures.
 - h. We need to reach out to past hosting Departments of past National Conventions for their input.
