

R. <u>Commandant's Report – Ric Ledford</u>

- 1. Thank you to all of the hard work done at the detachment level.
- 2. Full report:

It has been a strange few months since our Department convention in June. I am humbled and honored to be serving the Department for a third and final term. I thank all of you who have supported me and helped me since 2021. I has truly been a pleasure in spite of some issues we have experienced along the way.

Following our Dept convention I traveled to Baltimore, MD to attend the Mid East Division conference. I was very honored to be asked to sing the National Anthem for the opening ceremony.

Following the Mid East Conference the month of July was a flurry of activity and coordination across multiple Departments. I rode from our checkpoint up to TN and returned home. Multiple law enforcement agencies assisted with this effort. The day following this activity I was involved in a motorcycle accident myself. I am truly blessed that it wasn't worse than it was. I sustained 4 broken ribs (2 with multiple fractures) and a fractured pelvis. I was just released by the doctor 2 weeks ago to drive and return to my normal activities.

Needless to say, due to the accident, I was unable to attend the National Convention in OKC. Sr. Vice Commandant Robert Hare attended in my absence on behalf of the DoNC. Thank you for representing the Department Robert.

 - c) The department Instagram is up and running for the last 3 months. It has 497 page views (a page view is more than 30 seconds and 112 followers). DONCMCL is the name.

 - e) Hi Hello is a mobile business card app. It has a mobile QR code. This is more appealing to the younger generation Marines. Most younger adults do not carry a wallet or paper. They do carry their smart phone.
 - f) Scholarships can be used for high school or college age kids.
 - g) Make a local bar your Tun Taven. This is where we meet for staff meetings and after regular meetings. The bar also promotes us.
 - h) Billboard advertising companies are only giving 1 month use free to 501c3 organizations. Lamar billboards have some local ownerships who may work with MCL.
 - i) Recruitment Drive
 - DONC to improve membership we are going to host a Recruitment Drive will kick off at the conclusion of the Fall membership meeting October 28th through May 1st.

Idea is for members to benefit their local detachments and to use creative ideas to implement themselves into the community, this also allows for the leadership in the detachment to better utilize the reports sent per quarter to keep a more accurate record of members (Counts, Non-paid v paid, etc.). - iii. Reasoning behind the exemption from the Department dues stands as the department would not exist without the detachment members and 3 detachments being exempt from their department dues should not affect the treasury of the department in a matter that is detrimental. I would like to give the \$400 in prizes back to the 1st and 2nd place detachments from the department as a show of gratitude for their hard work during the drive, and because the department's treasury is built off the hard work of the detachments anyways. This money will come from the Junior Vice.
- 3. Judge Advocate –Bill Brown
 - a) Associate Members detachments can grant voting rights to your associates but it must be in the bylaws.
 - b) Social gatherings get together often for just having comradery.

- c) Bylaw Status The Department Bylaws have been updated with all of the approved changes from the Department Convention. Because we had five issues from the 2022 Bylaws submitted to National deemed to be not in agreement with National Bylaw or National Administrative Procedures (NBL/NAP) we are still awaiting release of the 2023 NBL/NAP. National Headquarters has indicated that they would prefer to only have to review Department Bylaws every 3-5 years given the sheer numbers and depth of reviews required. As such, I am seeking to include the newly approved 2023 National changes in our submission for review
- d) Detachment Bylaws and Sample Bylaws Updates I continue to work with several detachments that wish to update their bylaws and am simultaneously identifying needed changes to the Sample Bylaws. I am not pressing detachments hard on updating their bylaws until I have the Department's fully in compliance with National. I will begin contacting Detachments to update theirs as soon as that happens.
- e) Grievance & Charges For the current fiscal year there have been no departmental grievance hearings. When information comes to light of a situation I am quick to work with the Detachment to suggest means to mitigate the crisis and come to an amicable solution; sometimes that means identifying a neutral outsider from another Detachment to investigate and/or serve as a mediaor. As a reminder, before any grievance or disciplinary of charges come before the department, they need to be adjudicated at the detachment level. This has been reiterated by the National Commandant Baker and National Judge Advocate Porter on numerous occasions.
- f) National Bylaw and AP Amendments for 2023 There were 49 proposed changes, 4 NBLs, 43 NAP 2 combined. Of those, 24 were approved; 29 were rejected; and six were withdrawn. I personally submitted a total of nine, six were approved, two were rejected and the other is to be reworked as part of a larger re=write of NAP Chapter IX. Denny Mathias also submitted a number of proposals that were approved including a new formatting guidelines for future amendments. Unfortunately, the proposals were all deleted from the National website when the National Convention started, so we must await release of the 2023 NBL/NAP to actually see them.

- g) Need for Training I am looking forward to setting up some training hopefully in the next few months, possibly in Raleigh on a Saturday where the training could be between 1000 and 1500or 1600 allowing for more travel time and a break for lunch. More information will be worked out once we determine the priority of training to be conducted based on need.

 - a) Any submission of By-Laws They are due 60 days prior to the convention. April 9, 2024 is the deadline.

Just within North Carolina we have 46 Coordinators in 92 out of 100 counties statewide. Collected 674,127 toys, books and games were distributed to 260,650 children in need.

As you know, at the Oklahoma National Convention announced the Toys for Tots Program will expand to provide year-round support to children in need experiencing challenges and exceptional circumstances, thus sending a message of hope beyond the holiday season. The Foundation's year-round distributions reassure families who face adversity and exceptional circumstances throughout the year, that Toys for Tots stands ready to assist when emotional support is needed most. This support includes initiatives like our focus on assisting foster children. The Foundation may reach out to a select group of Coordinators for some of the yearround initiatives so we can have a greater impact on those children in need. They also looking to expand into assisting the children on Indian reservation. All of the new information will be in the 2023 SOP to guide you.

The Supplemental Toy Program and speaks to campaign sizes. The foundation made the decision to increase the number of campaign sizes from four to six. I believe this will provide better support to you with both the Supplemental Toy Program and Promotional Materials and Boxes.

 - c) Has heard that the scout masters and family are not reaching out. They think we are recruiting. Make sure they know we are not.
 - d) He had 36 sent in this quarter. We are number 1 in MED. We had 164 last year.
 - e) We can give a certificate to a person of any age. We can count the eagles for the past 4 years in our numbers.
 - f) We get requests from across the country to National, who pass them along to the local detachments.
 - g) We are working on making a standardized script / packet so anyone can present.

- h) We are working with the BSA to get us on the list on their website for recognition certificates.

- 3. Marine For Life Liaison Mark Munger (absent)
- 4. Young Marines Program Bruce Goeden
 - a) Wilmington unit is in need of assistance help.
 - b) I have just taken over the position of Liaison for the Young Marines program for the Department of North Carolina for a number of reasons which I wish to share with you:
 - i. Young Marines is a national, non-profit 501c (3) youth education and service program for both boys and girls, aged eight through high school graduation which started in 1950.
 - ii. The purpose of the Young Marines is to promote mental, moral and physical development of its members.
 - iii. The program focuses on teaching the values of leadership, teamwork and self-discipline, with emphasis on the importance of self-confidence, academic achievement, honoring our veterans, good citizenship, community service, and living a healthy, drug-free lifestyle.
 - c) Initially, after accepting the Liaison position, I was informed we have only 7 active units with a total Number of 68 Young Marines in The State. North Carolina currently has a Regimental Commander and a District 2 Commander over the Units.
 - d) My goal is for the Young Marines program to grow from the current 7 Units to a **minimum** of 20 Young Marine Units in North Carolina in order to reach as many of our youth as possible. And they need your help!
 - e) They need your help to start new Young Marine units, if there is not one already in your area of the State. Why you may ask? Because we want to give kids between 8 yrs and 18 a sense of family. A sense of purpose. A chance to make a difference in this crazy world.
 - f) They need your help financially. Please note, *there is no current Congressional Funding for the Young Marine programs*. Congress in their infinite wisdom decided this is no longer a needed program. Perhaps it's because they fear it might teach morals and accountability to our youth!

- g) We ask for you to become mentors to these Young Marines. How? By arranging with the Operational Units in your area to spend that most precious of commodities, **Time**, with these Young Marines where you can sit down with them to talk about your time in the Corps and what inspired you so you can inspire them.
- h) Our future is predicated on the teaching of our children. In spite of the current state of affairs in the World today, YOU. CAN. MAKE. A. DIFFERENCE.

 - b) This is also a concept to help with veteran suicide. Veteran Firearm Safety Team:

Why a VFST?

Veterans are 53% more likely to die by suicide than their civilian counterparts

From 2016-2020 the NC veteran death by suicide rate was 2.5 times higher than the general population

76% of deaths by suicide in NC are by firearm and this percentage is even higher for the veteran population

Veterans have unique training, experience and cultural affinity for firearms, requiring a veteran-generated solution to increasing safety during times crisis

Who Should Participate?

Although anyone with an interest in preventing veteran suicide is welcome, the following are highly encouraged to join:

- Veteran Service Organizations (VSOs) such as local VFWs, American Legions [WHO ELSE?]
- Pawnshops, gun stores, firing ranges, sporting clubs and other entities who interact with veteran firearm owners
- Non-profit organizations and other social service agencies who routinely assist veterans and their families who may be struggling
- Mental health professionals involved in providing behavioral-health care to veterans suffering from PTSD, TBI or suicidal thoughts
- ER staff, primary care doctors and other medical practices who provide veteran healthcare
- Law enforcement officers and first responders who routinely come into contact with potentially suicidal veterans

What a VFST Is\Does

An apolitical coalition of community stakeholders with particular knowledge of military culture and experience in enhancing the safety and wellbeing of veterans atrisk of firearm suicide and self-harm

Through a consensus-based strategic planning process, develops and facilitates best practices around safe storage policies and safety planning for at-risk veterans, including:

- Community outreach and education about the importance of providing safety alternatives to veterans during periods of suicidal crisis
- Validated messaging developed to effect desired behavioral outcomes
- Strategically distributes/provides options for acquiring gunlocks and other safe storage devices
- Helps establish peer support systems and safety planning practices for at-risk veterans

Relies on research and evidence to ensure strategies are implemented with fidelity and outcomes are measured to ensure effectiveness

What a VFST is NOT

A government entity or initiative that drives "top down" solutions

A gun control program that espouses "red flag" policies, background checks, or firearms bans

An advocate for or against any national, state, or local firearm laws, statutes, or regulations

 - a) This was a different kind of fundraising. This was shared 188 times across the country. It was viewed over 30,000 times. Sold 450 tickets sold. It was strictly word of mouth / social media sharing.

 - c) John Dilday Corporations usually are looking 2 to 3 years ahead for donations or grants. He has several corporations already lined up to request money from.

 - d) David Anderson He is here to make money for the department and not lose it to national.
 - e) There is an outside agency which national uses and they do a lot of the leg work.
 - f) Once we put in a letter of intent, Helms Bisco (57.00) handles the hotel. We work with items for activities. We have no input on the hotel.
 - g) The EBOT and David talked about this before this was brought up.
 - h) There is a publication on hosting of the national convention. It can be found on national website.
 - i) Approved by members present.
- 4. David Anderson made the motion for the department budget for 2024 be presented at the spring meeting to be voted on at the convention. Second by Jeffrey Jones.
 - a) A lot of folks want the budget ahead of time. We need to be able to discuss with our detachment members.
 - b) Approved by member present.
- 5. David Anderson made the motion that DoNC hire outside financial firm with no MCL association to audit going back to January 2021. Second by Alex Novgloski.
 - a) David Anderson Spring of 2021 department meeting, the members approved \$10K for A/V. In February 2022 BOT approved \$10,668.38 for A/V. He has asked for receipts for this money. A lot of money was spent on A/V and no receipts provided. He was provided with an inventory list. Things were bought and returned. If you were reimbursed then the money should be showing up.
 - b) Denny Mathias the invoices and receipts were submitted to the paymaster. The items bought and returned where shown on those submissions. A lot of the returns were not even on the submitted receipts. He welcomes this.

- c) Rick Thomas one detachment had an audit for 3 years it was \$5500 to do this.
- d) Bill brown these things were brought to the department for the last 2 years. We are operating for two fiscal years since.
- e) Keith Shearin time frame should not be an issue as we are required to keep records.
- f) Jim Mitchell on a zoom meeting we had asked the paymaster for a copy of the receipts over a year ago.
- g) Laura Hamilton The amount charged for the audit could be more since we are larger than a detachment. The \$72K in the checking account does have restrictions on how much could be spent. We would need to verify how much money is available to pay for such an audit.
- h) Kenny Joyner do we want to pay \$7,000 or more to find say \$500.
- i) Bill Brown a different paymaster was involved when this started.
- j) Denny Mathias will put together an expense report for anyone.
- k) Rick we will need to get an estimate for the cost of an audit. He stated the preliminary audit estimate was \$5K to \$10K. That detachment found out where the money went. There was no wrong doing found.
- 1) John Dilday With past financial experience you must give in writing to the paymaster a deadline for the data.
- m) Tom Lail we should get the receipts / invoices. Then go forward.
- n) Vote on David Anderson motion -19 in favor of the audit to 25+ not in favor of the audit.
- o) Jeffrey Jones we still need to get the receipts from Scott.
- 6. Kenny Joyner made the motion to give the paymaster 30 days to get the receipts to the EBOT. The letter will be from the EBOT. It will then be sent to the BOT. Second by Luke Winters. Approved by members present.
