# B. Training - 0822

- 1. Scott Shermeyer Paymaster / Adjutant documents
  - a) The unique Profile ID for each member / detachment / department. These must be on each transmittal.
  - b) Show of hands for a document manual was in the desire range.
  - c) We are starting in Google Drive a folder for each detachment to save their documents for any turnover of personnel.
  - d) He has updated some of the forms for ease of use and legible.
  - e) Correct information on the forms is very important.
  - f) Snail mail is OK to use, we just know that this is not fast in any means.

  - n) ROI. This can be emailed if from a known good email will satisfy signature requirement. Everyone listed must be installed. If they are done at a later date or a person is changed, then a new ROI for that person when installed. The persons must be in good standing with National.
  - o) Please no staples, paperclips.
  - p) There are several free software versions available to use for your computer to operate the forms.
  - q) Email is good for his contact as he works a job during the day.
  - r) ROI's need to be sent to both department paymaster and adjutant. We are working on a shared Drive folder to help make all of our jobs easier.

- s) He wants all snail mail addressed to the Department Paymaster c/o Scott Shermeyer.
- t) DVC's are asked to help the detachments with their paperwork.
- u) If a member is transferring and not paid up, they are not in good standing. If they pay and the transmittal is property filled out and sent up, they would then be in good standing for the transfer paperwork process. It would be recommended to include a copy of the transmittal to the paperwork showing they are paid.
- v) On the department website are a few training documents which are very helpful.
- w) 990's do not let them lapse.
- x) PLM (Paid Life Member) audit do not leave the money on the table. If you do not turn this in, the detachment and department lose money if this is not done.

Due to multiple causes detachment visits were limited.

- #848 has held two scheduled face to face business meetings for the 3<sup>rd</sup> quarter.
  Total paid members 58 with 8 unpaid regular and associate members. Various
  fund raising events were conducted and more to be done through the Apple
  Festival. Monetary and material Donations were made to multiple veterans
  groups. Recruitment is the detachments main goal for the next year.
- #1011 has held two meetings during this quarter. The detachment has had several job position changes during this reporting period due to member surgeries and illnesses. New members in the judge advocate and paymaster position need to be addressed. The last report submitted indicates 5.45% of members not in good standing. Total paid 52 with 3 unpaid members.
- #1417 held meetings in December, January, and February. Currently the 3<sup>rd</sup>
  quarter report indicates significant improvement over past reports. The report
  states that Det 1417 has 15.09% unpaid. The last report indicated almost 60%

3. Judge Advocate -Bill Brown

a)

In addition to the required duties of the DoNC Judge Advocate as defined in the Department bylaws, I have been working with several detachments to get their bylaws updated. My action items include:

- Review and approval of all Detachment Bylaws (DBL) and Administrative Procedures (DAP) ---Currently 28 or 60% of the 51 Detachments in the Department are 100% compliant with Bylaws that are current and certified. Of that I have soft copies for 53%.
- Grievances & Charges For this report period there have been no Departmental grievance hearings. I am hopeful that indicates that the Detachments are doing everything in their power to adjudicate or mitigate instances at their level
- I continue my work in developing procedural changes to both the DBL and NBL/NAP that will show that action to mediate grievances and/or disciplinary charges was taken prior to formally filing Chapter 9 proceedings and whether they proved successful. Additionally, we will work to show what documentation should be required at the Detachment and Department levels. These are not a part of the Chapter 9 process but really needs to be.

I incorporated and forwarded our changes from the Department Convention in May and forwarded them to the National Judge Advocate (NJA) for review and certification in November. The NJA completed his review and responded with further recommended changes. The majority of which were clerical in nature and updated paragraph references in the NBL and NAP which do not require approval by the Department membership. All the noted administrative changes have been made and will be annotated with "NRev" at the end of the applicable Bylaws section to indicate that they were identified as needing update upon National Review (i.e., (CH 5-22 NRev). This would mean a revision was made at the DoNC Convention in May 2022 and a reference update was provided by the National JA.

- (1) Section 101 CREDENTIALS, DELEGATES AND ALTERNATES removal of language restricting a newly formed Detachment (minimum 20 members to request Charter) to only 1 Delegate and 1 Alternate if they were formed too late to appear on the 31 March roster provided by National This is in conflict with NBL Article V, Section 505
- (2) Section 620 DELINQUENT MEMBERS-a need to include provisions to permit rejoining as a new member (R/I) via re-instatement and paying only current year dues. (This means a restart of the tenure date and its impact will likely require further discussion and/or revision).
- Section 705—INCORPORATION a need to delete outdated references,
- (4) AP Chapter One-- DEPARTMENT MARINE OF THE YEAR need to update the Marine of the Year Award of Distinguished Citizen Award (Silver) to the Department Marine of the Year Medallion and Ribbon,
- (5) AP Chapter One-- DEPARTMENT WOMAN OF THE YEAR (3) need to determine tehe fate of this award

I have already prepared change recommendations for all of those listed above with the exception of the Department Woman of the Year Award. Should we retain this or discontinue it altogether or create a new award for Associate Member of the Year award. It may be simpler to change the Woman of the Year Award AP to be Associate Member of the Year Award. I will include this as New Business in the Afternoon session.

There have been previous winners and we need to consider whether we wish to simply rename the award to Associate Member of the Year or not. Hopefully we will resolve this at the Spring Membership meeting.

Unfortunately, as I previously noted, except for what was approved in last May's Convention, our Bylaws had not been updated since 2018 and did not include all of the 2021 and 2022 NBL/NAP changes. This work will continue for some time to add them before the next Department Convention. I have identified the changes and continue to draft the needed changes to update them.

I have personally written over a dozen of those changes to comply with National's updates.

➤ A new change submission will permit any changes approved at a National Convention that mirror or reflect the same language at the Department level to be incorporated therein without having to either be voted on or to have to wait until the next DoNC Convention to become effective. This will also apply to typographical, spelling, formatting and renumbering of paragraphs. I will categorize them into two groups—Nationally Implemented and Department Member Approved

I have gone through all of the Detachment folders passed on to me when elected as Judge Advocate and compared them to the last Bylaws Status spreadsheet to determine what stage of completion each Detachment is. I wanted to confirm that we have the most recent Bylaws on hand, and if not, what would need to be done to get them completed.

I believe DoNC must be up to date before I can require that every Detachment is current with DoNC and National

I remind everyone that the Deadline for Submission of Changes to the 2023 DoNC Bylaws is 9 April 2023 – sixty (60) days before the Department Convention. The 19th was misquoted in the Agenda.

Similarly, the Deadline for Submission of Changes to the 2023 National Bylaws and Administrative Procedures is 16 May 2023 – ninety (90) days before the National Convention.

I will be reaching out to each Detachment Judge Advocate and Bylaws Committee to discuss their Bylaws status and how to best resolve bringing them current with DoNC and National. This is not a punishment to the Detachments but a means to inform and assist the members of all Detachments to the requirements and procedures under which we operate day-to-day.

I have a Zoom account and am willing to work with individual Detachments, the JA and the Bylaws Committees to update their documents. Zoom allows us to share screens and collectively update the documents (Bylaws, Admin procedures, SOPs, etc.,) that make the transition for newly elected and appointed officers or committee members a much shorter learning curve.

I have been working with the Sr. Vice Commandant, David Anderson, through the Commandant's Council to reestablish more involvement of the Detachments in Department activities and decision making.

During the 2022 DoNC Convention one of the proposed changes that was submitted and ultimately approved was:

ARTICLE TWO - BOARD OF THRUSTEES Section 200 - COMPOSITION:

In the previous (2018) edition of the Bylaws it read:

The Board of Trustees shall consist of the elected Department Officers, Department Junior Past Commandant or any appointed Past Department Commandant, <u>and all Detachment Commandants</u>. (CH 6-13).

I have re-written the definition of the Board of Trustees as follows:

Within the Department Board of Trustees it will be further categorized as the

- 1 Consolidated Board of Trustees Comprised of all elected Department Officers, the Junior Past Department Commandant or any Past Department Commandant selected at the Department Convention to serve as a voting member and all Detachment Commandants to rule on all financial and budget approvals and approval of nominations for vacancies of Elected Department Officers.
- 2 -- Executive Board of Trustees -- comprised of the Elected Officers and the Junior Past Commandant selected at the Department Convention to rule on all normal day-to-day operations identified within the Department operating budget, and the appointment and approval of staffing assignments and replacements for vacancies of appointed Department Officers.
- Lastly, the newly published NBLs/NAPs are now posted on the National website. While we make the changes required by National, you can begin seeing how the newer changes will impact your Detachments, to begin your updates, as well.
- b) Commandant Council meetings have started getting more detachment commandants involved.
  - Howard Boyd offered an option which should be included called Absolute Demit (sabbatical). This could assist members when they have a hardship and they need to take a sabbatical.

  - a) Any submission of By-Laws They are due 60 days prior to the convention. April 9, 2023 is the deadline.
  - b) Please do not send them at the last minute.
  - c) National changes must be on the website by 1 May 2023 (90 days prior to convention).

  - a) Gunny Clause is back up and running. About 2,000 children served.

- b) Had a handicap ramp request. A few organizations we were able to build the ramp.

1. Toys For Tots – Kevin Ashton

Just within North Carolina there was 46 Coordinators that ran campaigns all successful within 92 counties out of 100 statewide. Not all are MCL Local Area Coordinators. They were able to distribute 674,127 toys and supported 260,650 children. That was up from 32,510 more children you were able to support just in North Carolina than previous year. Keep in mind that's total toys distributed not collected as many campaigns keep small storage spaces of toys. Them toys are kept to help kick off next year campaigns. But also to assist any families in need threw out the year from displacement of fire, flood, hurricane etc. Also local emergency services do reach out to coordinators to keep plush and toys on hand in vehicles to help as they interact with kids on emergency calls. Toys For Tots helps threw out communities beside just Christmas times in the summer the foundation sponsors a Literacy Program since 2008. Click below for more information.
