Marine Harold Lefler, a charter member of our Detachment, became aware of a Marine in need. It seems this Marine had lost his legs in a post active duty event. He was sleeping on the couch because he could not get up a step to get to his bed in his wheelchair.

Harold contacted us on February 10<sup>th</sup>, the date of our meeting. We discussed it in the meeting and SVC Grace Shields said that she could make it happen. I figured that it would take me a few days to find people who had ramp experience and that we could get it done within the next couple of weeks. Later that evening, on my way home, I got a call from Department SVC Jeff Jones who was at our meeting. He said that he was not comfortable with this Marine sleeping on the sofa while we located people to help Marine Shields put the ramp together. He said that he could get a crew together and was thinking a completion date of February 13, 2016!



Well, with some quick work behind the scenes, Marine Jones arrived with his team to make it an all Marine crew. Our own Department of North Carolina Commandant Charles Minton and DONC Adjutant Rick Thomason rounded out the team. And on February 13<sup>th</sup>, one very cold day, four Marines made another Marine's life just a little better.

It would have been easy for the Department officers to say that this was a local problem and that, as State officers, this was not their problem. It is also good to see our Department and Detachment elected officers demonstrate the teamwork that our Corps is known for.
